

**PERFECT NORTH SLOPES – SKI TRAIN DEPOT
CONSIGNMENT AGREEMENT**

As the Undersigned, you are agreeing to the following:

1. I agree and warrant that I am the true and lawful owner of the consigned items.
2. I agree to pay a non-refundable per item charge of \$5.00 per item to consign. In addition, I agree to pay a commission of 15% of the purchase price on any items sold. I understand that optionally, 100% of my sale can be placed on a PNS Gift Card which can be used for any purchase at Perfect North Slopes.
3. **I agree that my unsold equipment after 11/2/24 will be transferred to inventory at Ski Train Depot, 1232 Bellview Dr, Greendale, IN 47025. I agree that Perfect North Slopes may continue to try to sell items on my behalf through 3/13/25. I agree that the list price of unsold items will be lowered by 20% on 1/20/25. I agree to pick up all unsold items before 3/13/25 at Ski Train Depot location or they will be deemed property of Perfect North Slopes.** I agree that Perfect North Slopes shall not have any responsibility for items left past 3/13/25.
4. I agree to price any consigned item in even dollar amounts. I agree that price changes or withdrawal of items will only be handled (authorized) at the check in area, with consignee present. I agree that any unauthorized price changes made on the tag will result in the merchandise being removed from consignment.
5. I understand that only hardgoods, (no jackets, ski pants, etc.) are accepted for consignment with the exception of straight skis & helmets. **I agree that PNS staff reserves the right to reject any merchandise deemed to be unsafe, unindemnifiable, of inferior quality or otherwise unacceptable.** I agree that PNS staff reserves the right to mark any equipment that fails visual inspection, per ISO standards, as such. I agree that all merchandise is sold, AS IS, WHERE IS, with no warranties, oral or written, express or implied, including without limitation the warranty of fitness for a particular purpose.
6. I agree that all payouts will be handled in the form of either a check or PNS Debit Card only. Payouts will be processed based on preference selected on Consignment Agreement. Payouts after 11/2/24 will be processed once per week and mailed to address listed on Consignment Agreement.
7. I agree that this Consignment Agreement is the sole agreement between the parties and no prior, simultaneous or subsequent understandings, representations agreements shall modify same. I agree that any modifications to this Consignment Agreement must be in writing and signed by both the undersigned consignee and the PNS staff.
8. I agree that the PNS staff shall use all reasonable methods of theft control, but is not responsible for any lost/stolen items and will not be responsible to pay for any lost/stolen items.
9. **I agree that by signing below, I, the undersigned acknowledges that I am bound by the terms and conditions of this Consignment Agreement.**
